The Victorian Government is banning e-waste from Victoria's landfill from 1 July 2019. New regulatory measures, in the form of waste management policies, have been developed to ban e-waste from landfill and specify how e-waste must be managed.

The VWMA is working with Grampians Central West and Barwon South West Waste and Resource Recovery Groups to run an all-day workshop about the ban, the campaign and related regulatory measures. Book places now as spaces are limited.
